Stage 2 – Institutional Report

1. A listing and description of all major instances of suspected foreign interference targeting Canada's democratic processes, including summary, dates, target, country involved, key players, information flow and any responses taken.

The *Criminal Code* does not have a specific section that is related to foreign actor interference, rather Criminal Code offenses address different types of conduct in connection with foreign interference, for example, sabotage, intimidation, computer hacking and bribery, to name a few. As a result, RCMP foreign actor interference investigations consider various Acts of Parliament. Investigators most commonly use the *Criminal Code* and the *Security of Information Act*, which provide the most all-encompassing enforcement capability when responding to reported physical acts of harm by operatives of hostile states. The files identified in the classified annex were investigations to assess if a suspicious person/event had caused an offence to occur. In some of these cases, no offence was determined to have been committed, and the files were concluded, while in others, ongoing efforts are underway to determine if a criminal offence has been committed. It is important to note how a concluded investigation may be reopened at any time when new evidence comes to light.

2. A listing and description of all existing means at the disposal of each government and agency to detect, deter and counter any foreign interference activities, including any relevant changes to or evolution in these means.

The RCMP employs a comprehensive approach to detecting, deterring and countering foreign interference. Central to our strategy is building robust networks to foster collaboration with partners, law enforcement agencies and other Government Departments. These networks serve as a conduit to share intelligence, facilitate joint operations and coordinate policy frameworks and legislative measures to mitigate challenges posed by foreign interference. In addition, through strategic engagement, proactive outreach initiatives, and community forums, the RCMP actively cultivates relationships with diaspora, enriching our capacity to adapt to evolving threats and supporting and protecting diaspora within the democratic framework.

Current Legislative Authorities

- When it comes to foreign actor interference as it relates to federal elections and democratic processes, the RCMP's national security program investigates threats to the security of Canadians by upholding various laws, including:
 - o Security Offences Act designates the RCMP as the primary enforcement body in relation to national security.
 - Security of Information Act contains numerous offences in relation to foreign interference, such as economic espionage,
 release of classified information, and foreign influence threats and violence.
 - o *Criminal Code* contains numerous offences that can be leveraged, including breach of trust, criminal harassment, unauthorized use of a computer, intimidation, bribery etc.
 - Canada Elections Act under a Memorandum of Understanding with the Commissioner of Canada Elections, the RCMP may
 participate in joint investigations with the Office of the Commissioner of Canada Elections at the Commissioner's request.
 - o Investment Canada Act review of foreign investments that may be injurious to Canada's national security.

Program and Policy Approach

• **Federal Policing National Security** is mandated to prevent, detect and respond to national security criminal activities. Investigations are led by Integrated National Security Enforcement Teams and National Security Enforcement Sections, located in Divisions across the country. Integrated National Security Enforcement Teams and National Security Enforcement Sections are centrally governed by National Headquarters and undertake national security criminal investigations into terrorist activities, further to the

antiterrorism provisions of the *Canadian Criminal Code*, as well as any occurrence arising out of a threat to the security of Canada, under the *Security of Information Act*. Within Federal Policing National Security, the Foreign Actor Interference Team was also created in 2020, with the specific mandate to detect, investigate, and disrupt foreign interference.

- **Federal Policing Protective Services** coordinates and oversees the delivery of protective services to Canadian executives, visiting foreign dignitaries, and designated persons, and the security for all designated major events. In addition, the Program provides guidance, support, reviews and assistance on protective policing activities including those of the Divisional VIP units, the Prime Minister Protection Detail and the Governor General Protection Detail.
- Federal Policing Criminal Operations manages the oversight and governance of files relating to serious and organized crime, financial crime and cybercrime. It is also responsible for sensitive international investigations, covert operations, operational information and data science, and the federal Witness Protection Program. Specifically, for cybercrime, the focus is on criminality involving the use of computer systems with high economic or cross-jurisdictional impact and national interests of significance to the domestic or international law enforcement community. This could include cybercrime directed against institutions of government, critical infrastructure of national importance, or key Canadian institutions and business assets.
- Federal Policing Intelligence and International Policing is responsible for developing operational and strategic national criminal
 intelligence, overseeing Liaison Officers and analysts deployed oversees, and Canada's international police peace operations.
 Strategic intelligence analysis is also undertaken to provide senior executives (Director General level to the Commissioner) early
 warning and strategic assessments on emerging threats, trends, and international incidents that may impact Federal Policing
 priorities.
- Federal Policing Strategic Management provides strategic engagement with key national and international stakeholders, and
 raising awareness of federal priority enforcement areas through crime prevention and reporting initiatives. Federal Policing
 Strategic Management provides national security policy advice to senior leadership within the RCMP, as well as to other
 government departments and agencies, and is the conduit to the RCMP for review and oversight bodies. It also leads initiatives on
 Federal Policing priorities to enhance reporting on associated criminality, prevent victimization and bolster investigative e fforts.
 This includes:
 - Organizing programming at the community level aimed at fostering dialogue and increasing trust and collaboration between law enforcement and community groups.



- Developing and translating educational and awareness materials into various dialects, publications and presentations on critical issues (foreign actor interference, threats and intimidation).
- Collaborating with the public and other stakeholders (e.g., community leaders, religions institutions, police of jurisdiction etc.), to establish tailored outreach initiatives that address the needs and concerns of diaspora communities.
- o Providing culturally sensitive support, during times of crises, to diaspora communities affected by incidents (e.g., hate crimes).
- Leveraging various social media platforms to engage diaspora communities, and delivering outreach programs focused on engaging and building trust and resiliency amongst youth within diaspora communities.

Collaboration with the Security and Intelligence Community and other Partners:

- Within the context of foreign actor interference in democratic institutions and processes, the RCMP works closely with Other Government Departments (ODGs) and partners in the Security and Intelligence (S&I) community, both domestically and internationally, to coordinate efforts and address complex issues that require multi-agency response. Including:
 - Since 2018, the RCMP remains a participant on several governance committees related to national security, with a focus on protecting democracy:
 - Deputy Minister, Assistant Deputy Minister and Director General foreign interference committees on China and India
 - Deputy Minister and Assistant Deputy Minister National Security Committees
 - Deputy Minister Committee on Intelligence Response
 - National Security Council and Director General Plan to Protect Democracy Committee
 - Deputy Minister Operational Coordination
 - Deputy Minister Intelligence Committee
 - Deputy Minister Review Coordination
 - Deputy Minister-Clerk on Foreign Interference
 - Deputy Minister Committee on Foreign Interference
 - Deputy Minister Committee on Cyber Security
 - The RCMP works in conjunction with the Canadian Security and Intelligence Service (CSIS) and other agencies to improve the flow of intelligence and identify and counteract threats to national security, such as foreign interference. Key policy milestones to date include:
 - Operational Improvement Review: In 2017, CSIS and the RCMP proactively launched a review to better diagnose challenges and identify solutions to improve cooperation. Of the 76 recommendations found in the review, 45 are specific to the RCMP.
 - The Quad Memorandum of Understanding (Signed October 2020): Provides a process whereby counsel from the DOJ can cooperate with the PPSC and CSIS in identifying vulnerabilities at pivot points in investigations and prosecutions, and addresses the role that PPSC would play in proceedings falling under s. 38 of the Canada Evidence Act.

- The One Vision 3.0 Framework (Signed November 2021): Updates the principles for information sharing, continuing to emphasize that public safety, as opposed to prosecution, is the gold standard. It also formalizes a role for the PPSC in the One Vision process.
- The RCMP has a mandate to support the Commissioner of Canada Elections with technical support and joint investigations, upon their request, should they deem there has been an illegal act committed with respect to a federal election. In the case of an investigation, both Elections investigators and the RCMP jointly assess cases and recommend mutually acceptable plans of action.
- The RCMP collaborates closely with the Five Eyes community to tackle shared challenges. The RCMP shares trends, knowledge of various threats, tactics, and processes to stay informed and prepare for potential security threats and to prepare join strategic assessments.
- The RCMP is a participant on the Security and Intelligence Threats to Elections Task Force, along with other S &I agencies. The RCMP's main operational focus within the Task Force is to provide law enforcement expertise, criminal intelligence collection, analysis, and assessments to support the Task Force mandate of reporting on covert, clandestine, or criminal activities interfering with, or influencing, electoral processes in Canada.
- The RCMP also participates in the Task Force related briefings to Government of Canada senior management, the Panel of Five, and to the campaign leaders of the various political parties, as required. Through the Task Force, the RCMP could also investigate any criminal activity relating to the interference or influence in Canada's electoral process, and works in partnership with other law enforcement, intelligence, and regulatory agencies to respond to treats to elections.
- The RCMP participates in the Critical Election Incident Public Protocol and in intelligence briefings to the Panel of Five on emerging national security threats which pose a threat to Canada's electoral processes. Along with its Task Force partners, the RCMP contributes information and intelligence to support awareness around possible threats to electoral processes and decision-making.
- The RCMP participates in the G7 Rapid Response Mechanism. This initiative is led by Global Affairs Canada and various Election Security Coordination Committees, co-chaired by the Privy Council Office and Elections Canada. The G7 Rapid

Response Mechanism monitors and produces reporting on the evolving threat environment of foreign interference-related activities targeting Canada's, and the broader G7's, democratic institutions.

Outreach and Engagement Approach

- The RCMP extends its strategic engagement efforts beyond traditional law enforcement activities, actively fostering connections and trust within the four Federal Policing regions' diverse communities. Through proactive outreach initiatives and community forums in Divisions, the RCMP collaborates with local police and community stakeholders to nurture relationships with diaspora populations and ensure their protection within the democratic framework. This comprehensive approach includes:
 - Tailored Engagement with Diaspora Communities: The RCMP proactively engages with diaspora communities to understand
 their unique needs and enhance service delivery. By building trust and forging partnerships, the RCMP strengthens community
 safety and well-being, fostering a sense of belonging and inclusion.
 - Cultural and Educational Initiatives: To deepen relationships, the RCMP conducts engagement and educational initiatives with
 diaspora community leaders, participates in cultural events, and raises awareness about the role of law enforcement in
 community building. These efforts not only promote understanding but also facilitate meaningful dialogue and collaboration.
 - Responsive Engagement: In response to significant events within communities or geopolitical developments, the RCMP directs focused engagement efforts to address emerging concerns and support community resilience. Whether attending cultural and/or religious events or providing informative presentations on foreign actor interference, the RCMP demonstrates its commitment to engaging proactively and inclusively with all segments of society.

The information presented below does not include matters subject to Cabinet Confidence, including pending requests:

- In 2018, the RCMP established a temporary team dedicated to investigating foreign interference activities.
- In January 2019, the Government of Canada announced the Plan to Protect Canada's Democracy. The Plan established or formalized several mechanisms and initiatives, including direction for the RCMP to form a team dedicated to investigating for eign interference activities.
- In 2020, the RCMP's temporary investigative unit was formalized into the Foreign Actor Interference Team, who provide oversight of the RCMP's foreign interference investigations across Canada, but who do not directly conduct these investigations.
- Budget 2023 and 2024, funding was granted to combat Foreign Actor Interference.
- In 2024, RCMP contributed towards legislative changes of Bill C-70 which received Royal Assent in June 2024.
- In March 2024, the RCMP contributed to Public Safety-led response to M-112 Political interference, violence, or intimidation on Canadian soil.

4. The RCMP does not possess a Memorandum of Understanding explicitly tailored to address foreign interference. Rather, the RCMP maintains various arrangements with partners to foster multi-agency collaboration, facilitate information sharing, conduct national security investigations, and engage in international cooperation, including efforts to counter foreign interference activities. Below is an outline of some of the existing arrangements that facilitate our collaboration with government departments, agencies, and international partners. This includes agreements with OGDs and Agencies, Five Eyes Partners and with other foreign nations and/or international law enforcement. While these agreements are not solely focused on foreign actor interference, they are premised on the exchange of information and intelligence to support cooperation as it pertains to investigations, projects, initiatives or other operations.
