Declaration of Zhao Wei as PNG

This document is an unclassified summary of intelligence held by Security and Intelligence departments and agencies. It has primarily been created by Global Affairs Canada, with input and agreement from the Canadian Security Intelligence Service, and the Privy Council Office. It responds to a specific request by the Commission for the Public Inquiry into Foreign Interference in Federal Electoral Processes and Democratic Institutions, for an unclassified summary of information regarding this particular topic and should not be used as the basis of understanding for any other topic. This document is based on intelligence collected and assessed over a period of time and does not necessarily reflect the Government of Canada's full understanding of the topic at any specific point in time. The underlying intelligence has been provided to the Commission. By employing summaries and redactions, this document sanitizes intelligence in a manner that removes the potential injury to national security and international relations, does not disclose sensitive activities, techniques, methods, and sources of intelligence that would cause potential injury, and abides by relevant Canadian legislation. It does not provide allof the caveats and limitations contain ed in the original classified documents or provide an assessment of the reliability or credibility of any specific piece of intelligence, as it could disclose information that would cause injury.

This is a summary of some intelligence information that is available to the Government of Canada's national security and intelligence community on a certain topic, presented such that it can be released to the public without disclosing information that would cause injury to national security and international relations. As such it has several important limitations. The summary must be read in light of these limitations, otherwise the summary has the potential to mislead the reader . The limitations are the following:

- Summary may be incomplete: The summary summarizes some, but not necessarily all, the intelligence information on
 this topic that is available to the Government of Canada's national security and intelligence community. For example,
 it only contains relevant information that can be appropriately sanitized for public release.
- Summary does not indicate time of collection: This summary does not indicate, unless expressly stated, when the
 summarized information was collected or obtained. This information was collected and analyzed over a period of time,
 which may/may not have been available to decision makers across the Government of Canada during the writ-period.
 As such, for example, it should not be assumed that the information was collected close in time to the events being
 described.
- Summary may contain information that is single-sourced: The summary does not indicate whether the information it
 relates comes from a single source, or from multiple sources.
- Summary may contain information of unknown and varying degrees of reliability or information that may have been provided to influence as much as inform.
- Summary does not indicate the source of information: The summary may present information from different types of
 sources without identifying the type of source (i.e. open source, human sources, technical intercepts, etc.). Nor, does it
 indicate whether it was translated from another language than the language in which it is presented.
- Summary does not indicate corroboration or lack of corroboration: The summary does not indicate whether other
 information exists that may corroborate the summarized information, or, alternatively, whether there is no such
 corroborating information.
- Summary does not analyze information: This document is a summary of intelligence; it is not an analysis of the
 overall import, meaning, or strength of intelligence.

The Commission has been provided with all relevant intelligence and assessments, which indicates information on reliability and corroboration of the information contained therein.

Declaration of Zhao Wei as PNG

- 1. Zhao Wei was an official at the People's Republic of China (PRC) Consulate General in Toronto who arrived in Canada in April 2018. As of May 8, 2023, Zhao Wei was declared *persona non grata*, and left Canada.
- 2. During the timeframe under review by the Commission, Canadian Security Intelligence Service (CSIS) and Global Affairs Canada (GAC) formally exchanged information on several occasions regarding foreign officials suspected by CSIS of conducting foreign interference activities in Canada. CSIS also disseminates intelligence to relevant Government of Canada partners concerning any suspected threat related activity undertaken by foreign officials.
- In January 2022, during the first high-level engagement between Canada and China following the release of Michael Kovrig and Michael Spavor, the Deputy Minister of Foreign Affairs raised concerns about foreign interference and the activities of the United Front Work Department (UFWD) with her Chinese counterpart.
- 4. From January 2022 until April 2023, Government of Canada officials repeatedly raised foreign interference with the PRC counterparts, including at the foreign minister and leader levels. During this period, Canadian officials made it clear that if the foreign interference continued, PRC would face increasing consequences from visa delays to visa denials, and position-creation denials. Specific concerns were raised, including with respect to the activities of PRC diplomats, the presence of PRC police stations, and the overflight of "spy balloons". Additional information can be found in the summary "The PRC Targeting of Parliamentarians for the Purpose of Exerting Influence."
- A limited number of CSIS intelligence reports referencing the PRC's interest in MP Michael Chong were produced and sent to GAC prior to May 2021. These reports do not link Zhao Wei to foreign interference activity.
- 6. On May 1, 2023, the Globe and Mail published an article linking Zhao Wei to the targeting of Michael Chong. Media appears to have reached this conclusion based on their own interpretation of some events summarized in the topical summaries on "The PRC Targeting of Parliamentarians for the Purpose of Exerting Influence" and "Michael Chong".
- 7. A separate body of inteligence reporting suggests that some of Mr. Zhao's activities while serving as a diplomat in Canada constituted foreign interference. Given the repeated efforts described in paragraph 4, along with the impact of the article published on May 1, 2023, which effectively meant that Mr. Zhao could no longer function as a diplomat in Canada, on May 4, Deputy Minister of Foreign

Affairs, David Morrison, called in the PRC Ambassador in Canada to advise that Zhao Wei's position in Canada was no longer tenable. From May 4 to 8, 2023, Mr. Morrison and Canada's Ambassador to the PRC conducted a series of high-level *demarches* with PRC counterparts to convey Canadian concerns, again referring specifically to the activities of PRC diplomats, the presence of PRC police stations, and the overflight of "spy balloons".

- 8. On May 8th, 2023, the Minister of Foreign Affairs announced that Canada had declared Zhao Wei *persona non grata*.
- 9. On May 9, 2023, the PRC Ministry of Foreign Affairs declared a Canadian diplomat *persona non grata*.
