- The columns N2045, NS Primary Unit, and NS Assisting Unit capture the number of times each
  classification of unit is linked to an occurrence. While the column Annual Total captures the total
  unique occurrences. (For example, if a single occurrence had 3 separate NS units linked (1 as primary, 1
  as assisting, and 1 as N2045), each corresponding column would include this occurrence in its counts.
  However, if you were to look at the Annual Total, it would only indicate a single unique occurrence.)
- 2. An occurrence was categorized as "Linked to Foreign Interference" if two criteria were met:
  - i. One of the National Security Units was linked to the occurrence as 'primary' and/or 'assisting'
  - ii. It contained one of the Foreign Interference UCRs
- 3. Query results are effective on the date completed (2023-09-13) and are subject to change.
