I am also not sure why they provided them all by screengrabs. (every single item is either a jpeg file, or a pdf.) My guess is they suspected the WeChat articles were in danger of being taken down after the election; a situation like that happened in 2019 during GE43.

As far as I can tell, all the wechat articles and Chinese-language news sites are still up. I have been using two websites – archive.is and archive.org – to keep a live snapshot of what we monitored on wechat and social media during GE44 instead. It's certainly not ideal for us to research using pdf files. Taking screengrabs is not a good way to OSINT research.
