CLASSIFIED NATIONAL SECURITY BRIEFINGS TO OPPOSITION LEADERS

(Decision Sought/Signature Required)

SUMMARY

- It is proposed that classified briefings be offered by Canada's security agencies to leaders of recognized political parties in the House of Commons on national security matters, such as foreign interference and domestic extremism. These quarterly briefings would support better-informed policy debate and better position Canada's political leaders to take action to protect themselves, their parties and Canada's national security from specific threats. The first briefing would offer an overview of the intelligence community's activities, processes and priorities, and would then focus on foreign interference in past federal elections.
- To facilitate these briefings, it is also proposed that the leaders of recognized political
 parties each be processed for a TOP SECRET security clearance and be briefed on
 receiving and handling classified information. Together, these measures would enable
 Canada's security agencies to prepare and deliver tailored, classified briefings up to
 the TOP SECRET level to them as needed.
- These briefings would also respond to a 3 May 2023 letter you received from the Honourable Jagmeet Singh. In his letter he asked that you meet with opposition leaders to provide information about how Members of Parliament are kept informed about threats against them and their families from foreign governments.
- If you agree with this proposal, please sign the enclosed letters to Opposition Leaders
 (Tab A) advising them of the opportunity for classified briefings. Once received, PCO
 will liaise with the offices of the leaders of the recognized opposition parties to ensure
 security forms are properly filled out and submitted. Upon receiving clearances, PCO
 will then work to coordinate the briefings.
- Do you agree?

Background

 Recent media reports have brought attention to allegations of foreign interference in Canadian democratic processes during the 2019 and

2021 General Elections. These allegations have led to calls for a public inquiry into foreign interference in Canada. Debate on these issues has been ongoing in the House of Commons, including within the Standing Committee on Procedure and House Affairs (PROC).

- The National Security and Intelligence Committee of Parliamentarians (NSICOP) recommended, in two separate reports in 2018 and 2019, that "[in] the interest of national security, members of the House of Commons and the Senate should be briefed upon being sworn-in and regularly thereafter on the risks of foreign interference and extremism in Canada."
- On 3 May 2023, the Honourable Jagmeet Singh wrote a letter to you (Tab B) asking you to "urgently meet with all Opposition leaders to outline how [threats from foreign governments directed at Members of Parliament and their families] are received by you and the Minister of Public Safety, what you do with this information and how MPs are kept informed."

Proposal

- In view of ongoing debates around foreign interference, democratic processes, and growing threats to Canada's national security, it is proposed that classified briefings be offered to the leaders, or interim leaders, of recognized political parties in the House of Commons. In the near term, this would serve to shed light on allegations of foreign interference in political spheres. It would also highlight other threats to Canada's national security, political parties, and parliamentarians themselves.
- Such briefings would support informed policy debate on foreign interference and other national security threats, such as violent extremism. The briefings would better position Canada's political leaders to take action to protect themselves, their parties and Canada's national security. This initiative could also signal publicly that Canada and all Canadian political parties take threats to national security seriously.
- The focus of the briefings would be to provide opposition leaders with information that is not available publicly, or through the regular means by which officials provide unclassified information to Parliament. As such, it is envisioned that the briefings would be typically delivered at the SECRET level, though with the option of going up to TOP SECRET if required. Care would be taken to protect all Cabinet Confidences.
- Individual classified briefings would be offered to official party leaders exclusively and would be delivered in person in a secure location in Ottawa. This format would allow to increase awareness of those key

elected officials while adequately protecting classified information. PCO would coordinate the briefings, which would involve senior representation from the Canadian Secret Intelligence Service (CSIS) and the Communications Security Establishment (CSE), and would take place every four months, or as needed.

- PCO would advise your office of the dates and topics in advance of the briefings. The first briefing would offer an overview of the intelligence community's activities, processes and priorities, and would then focus on the foreign interference threat, including - in past federal elections. The first briefing would also respond to Mr. Singh's request for information about how information on threats to Members of Parliament and their families are managed. Future briefings would prioritize the most pressing national security topics of the day, potentially including foreign interference and ideologically motivated violent extremism.
- If you agree with this proposal, please sign the enclosed letters to
 opposition leaders that lay out the initiative, and explain the clearance
 process as the mechanism to offer them classified briefings. PCO will
 engage with opposition leaders' offices to ensure that security
 clearance paperwork is properly filled out and submitted. Upon
 confirmation of clearances, PCO will coordinate the briefings, in
 consultation with your office.

Considerations

- As lawmakers and politicians, all Members of Parliament are at risk of being targeted by foreign interference actors and, increasingly, by domestic extremism, as are many of their constituents.
- Based on the experience of the Security and Intelligence Threats to Elections (SITE) Task Force in the context of previous federal elections, some party leaders may choose not to accept an invitation to classified briefings. Nevertheless, offering these briefings to opposition leaders would reiterate our commitment to transparency.

Dear Prime Minister,

The public revelations of the threats from a foreign government directed to a Member of Parliament and his family have been shocking.

Members of Parliament must be able to do their jobs without fear. They must be able to ask tough questions and stand up against human rights abuses and know that their security will be protected. This is an expectation that every Canadian should have of their government.

So far, neither you nor your Minister of Public Safety have been able to offer Members of Parliament or Canadians any assurances that if they or their families are threatened by a foreign government, your government will inform and protect them. This is of great concern.

I appreciate that you have made an offer to brief the affected member of Parliament, Mr. Chong. This offer is coming only after the information was made public and almost two years after the threats were made. This utter lack of urgency and action is unconscionable.

I believe that this is an issue that could impact all Members of Parliament. Any MP could be subject to similar threats. There are members in all our caucuses who have loved ones in countries where they may be subject to threats. I am therefore asking you to urgently meet with all Opposition leaders to outline how such threats are received by you and the Minister of Public Safety, what you do with this information and how MPs are kept informed.

To be clear, I am not asking for you to release any information that could harm national security. I am simply asking for a clear process of how evidence of foreign interference directed at Members of Parliament and their families is handled by your office.
