

direction, is to offer regular briefings to leaders of opposition parties on a variety of subjects, including classified intelligence and information when appropriate. The intention of the briefings will be to allow parties to develop more informed positions on issues relating to national security, foreign policy, defence, or other topics. They would also provide a venue to disclose information specific to parties to help address national security issues, such as when a particular party may be subject to directed foreign interference attempts.

	<ul> <li>Opposition party leaders will first need to obtain a TOP SECRET security clearance</li> </ul>
	and appropriate indoctrinations to receive the briefings, and PCO can reiterate the offer you have already made to leaders to receive such a clearance.
	<ul> <li>The protocol has been discussed with key DMs who were all in agreement of the overall approach. It is understood that risks are not zero (e.g. parliamentarians may choose to disclose classified information in the house and claim parliamentary privilege), but we are able to mitigate through the clearance process and eliminating/restricting access to future information should there be inappropriate disclosure.</li> </ul>
	<ul> <li>The protocol would include working with your office to confirm agenda topics/subjects, informing you of what will be briefed in advance, and following up with your office on any outcomes.</li> </ul>
	<ul> <li>PCO would coordinate the briefings, working with security agencies, and deputies would be responsible for briefing their ministers accordingly.</li> </ul>
	<ul> <li>A specific note detailing the proposed protocol and considerations will be provided</li> </ul>
