As the SITE TF Chair, CSIS provided an overview of the SITE TF mandate, definition of FI and invited the other SITE members to speak about their roles and responsibilities. CSIS then provided an overview of the FI more generally and the type of tradecraft used by Hostile State actors and generally what this may look like. CSIS also provided an overview of the types of activities of the PRC, in particular. Finally, [REDACTED]

[REDACTED] I have attached my talking points to this email which were a mixture of previous political party briefing notes and DIR unclassified talking points provided by PFR.

Overall, I felt that the briefing went well. I noted that political party representatives appeared engaged during parts and were nodding their heads or taking a few notes. There were no questions at the end of either presentation.

PCO noted that they felt that the examples were not concrete enough in relation to actual FI witnessed by the departments or SITE. In this vein, PCO thought that the briefing did not hit the mark nor meet political party expectations. On this note, we will be asking the SITE TF to begin to develop some examples that can be anonymized that speak to FI in reality and translated to be available for any future requirements.
