#### Diplomatic representations / engagement with the PRC Embassy

Different streams/branches of Global Affairs Canada regularly engage with the PRC Embassy through calls, démarches, and letters at various levels for a wide array of day-to-day business. For instance, the Asia Branch frequently speaks with officials from the Embassy on various topics, including the state of bilateral relations, international defence and security issues, visits, culture, diplomatic visas, education, consular, embassy security, or trade/commercial matters.

The issue of foreign interference, surveillance, and issues involving the security of Canada have been raised on multiple occasions and at various levels by GAC officials since October 2021. Importantly, the issue was **raised on 17 January 2022** by then-Deputy Minister of Foreign Affairs Marta Morgan, directly to her counterpart Vice Minister Xie Feng.

Overall, there were <u>31 representations</u> at all levels (through diplomatic channels) on the issue of foreign interference, surveillance, and issues involving the security of Canada. **25 were made by Headquarters** (including at the highest levels) and **6 in Beijing.** Breakdown and details as follows:

### By Headquarters

- 2 February 2023: DMA to Ambassador Cong in-person– Démarche on intrusion of surveillance balloon in North American airspace. DMA also references other unacceptable behaviours by Chinese authorities, including interference, police stations, and malign cyber activities.
- 21 February 2023: OPB to DCM Zhao (foreign interference and surveillance balloon),
- 24 February 2023: aOGM to Ambassador Cong (police stations and foreign interference) delivery of second Note Verbale on police stations.
- 2 March 2023: MINA raised foreign interference in pull-aside with Chinese counterpart Qin Gang at the G20 FMM in New Delhi.

- Canadian diplomatic footprint in China: 148. Canadian embassy in Beijing: 81 positions (of which 71 staffed); CHONQ: 5; GANZU: 15; SHNGI: 23; HKONG: 23.

**Note:** Chinese footprint is diplomats registered with the Protocol Office in Ottawa. Canadian footprint is based on number of positions allocated, but excludes Temporary Duty officials. Positions allocated are higher than positions staffed due to officials not occupying their positions for reasons such as visas or COVID restrictions.

**Note 2:** The above numbers on diplomatic representation as well as numbers provided previously about diplomatic representation in the note titled "23. Diplomatic Representation in Canada / in China" are publicly available but difficult to compile. There would be no concerns about MINA stating the numbers for China and Canada during the appearance. The other numbers provided, such as those for the UK diplomatic presence or that of Japan, while publicly available, may cause discomfort to our partners if they are used by the Minister during the appearance, but may be used with caution on a responsive basis should they be required to illustrate a point. They would have to be released under proactive disclosure, however, as they are publicly available.
