Action Required: Participation at Election Security Coordination Committee (ESCC)

Carmen,

As you are aware, there are various committee meetings in preparation for, and during, by-elections and a general election, to coordinate election security activities. In the past, our office was invited to participate in DG, ADM and DM committees. Other participants included Elections Canada, CSE, CSIS, RCMP, PCO and public safety.

Meetings are underway for the by-elections. Invitations for the 45th GE will be provided when the GE is called (if snap election), or as we get closer to fixed date general election.

As part of my oversight of general election planning for our office, the identification of the participants for our office is important and is documented in the GE workplan.

For the 2019 and 2021 GEs, participants for the OCCE were as follows:

DG level : Jean-Michel Kalubiaka
ADM level : Marc Chénier
DM level : Yves Côté

In 2023, the CCE appointed Christina Maheux to the ADM level meetings. Given Christina's absence, and the current byelection, immediate decisions are required as to the OCCE participants for our office

Based on my general understanding of these meetings, the participants should understand the scope and limitations of your mandate, the CEA, as well as the operational issues that may arise in the electoral context. Among others, table top exercises were conducted in the past, whereby interventions were required in response to the issues presented by the other participants.

In 2019, there was discussion of my participation at the DG level committee meetings, however, it is my understanding that general concerns were expressed by PCO of having someone responsible for investigations be of attendance, given the expectation that intelligence briefings could/would be presented in these meetings. With that understanding, the OCCE may have a reduced pool of potential candidates for the enforcement directorate, although updated responsibilities and delegations, including the recent addition of the Executive Director Enforcement position assists in this regard.

Given the above, I recommend as follows:

- ADM level meetings Carmen Boucher
- DG level meetings: Jean-Michel Kalubiaka (no change)
