

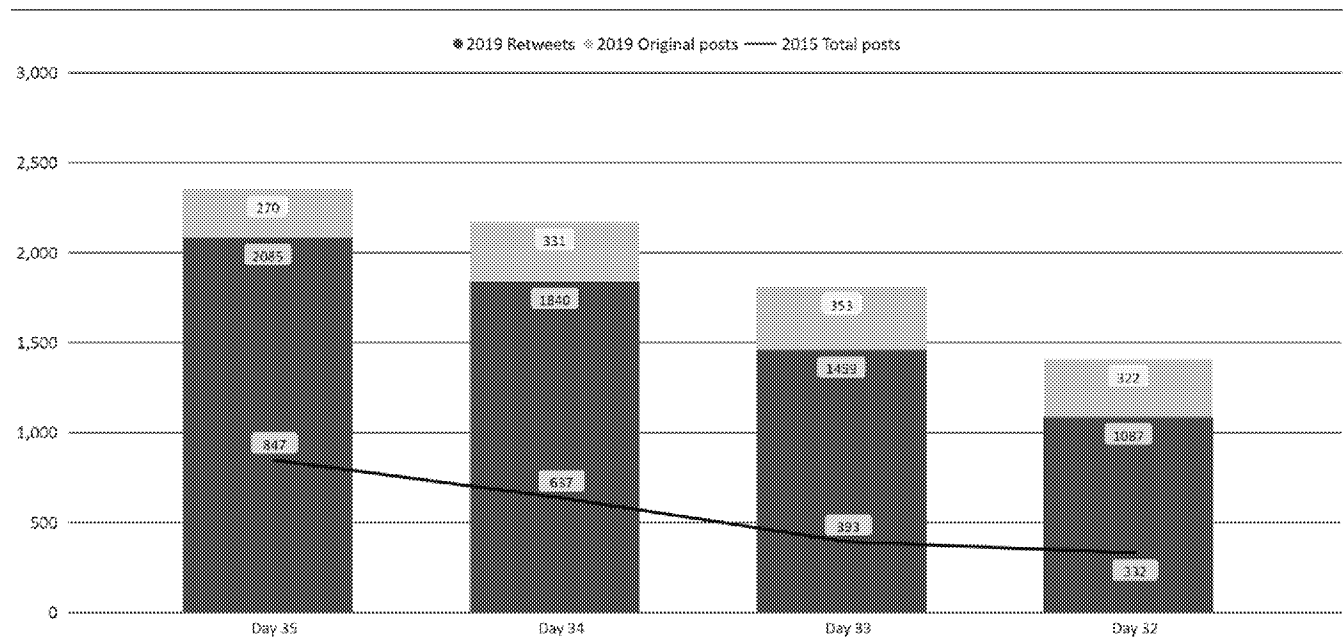

Social Media Monitoring Report: noon September 19 to noon September 20, 2019

Observations principales / Key observations

- Users on a niche Reddit forum accused EC of “doxing” CNP members, following the release of party member names and cities of residence
- Twitter users alleged that the surfacing of a 2001 photo of LPC Leader Justin Trudeau in brownface makeup is “foreign interference” by powers wanting to “influence” GE43
- A number of Twitter users expressed confusion, frustration over the lack of a complete list of candidates on EC’s website

Éléments sous observation / On the radar

Twitter user expressed dismay over candidate’s truck, covered in partisan signage, parked in front of the RO office where voting is taking place: A Twitter user (312 followers) shared a photo of PPC candidate Sean Taylor’s campaign truck parked near the entrance of an EC office, and expressed concern that it might violate electoral laws. The user also claimed that advance polling began on September 18 and that voters were inside the office when the photo was taken. Another user replied to the post, stating that advance polling starts on October 11 and speculating that the photo was from a by-election. The original user replied that since it was possible to vote at EC offices “between now and October 15,” the location should be considered a “polling place.” The post garnered 3 engagements. SMMU has determined that the photo was taken at an EC office on 502 Martin Street in Penticton BC and was not from a by-election; GE43 is Taylor’s first time running as a candidate.



- **Twitter user revived criticism of the “influencer campaign”:** Following a tweet by *InfoWars* reporter Paul Joseph Watson critical of Lilly Singh, a Twitter user with 4.2K followers brought up Singh’s role in EC’s cancelled campaign to promote youth registration. The tweet received 14 engagements. A second user with 1.4K followers replied to the post, and said EC “is a communist run organized crime syndicate.” The comment had zero engagements.
- **Friends of Science continued to thank EC for its statement on climate change:** Over a month after EC made its statement on environmental groups and third party registration, Friends of Science (23.7K followers) continues to thank EC for its warning that “climate talk” could be a partisan issue. The group has been extensively using Twitter and LinkedIn to share a *Toronto Star* article that discusses the group’s “alternative views” on man-made climate change. A recent Twitter post by the group received 15 engagements.
- **LinkedIn user stated that Amnesty International should be a registered third party:** A user with 4.5K followers accused the Secretary General of Amnesty International Canada, Alex Neve, of conducting political activities at the provincial and federal levels and of “using tax dollars to travel to Alberta to the U of A to continue his political attacks.” The user also stated that Amnesty should be registered as a third party and subject to Elections Canada rules. The post received 66 engagements.

- **Tumblr user reshared September 14 post claiming all Canadians are “automatically registered” to vote when they turn 18:** The reshared post received 294 engagements.
- **Twitter user asked whether GE43 would be rescheduled in the event LPC Leader Justin Trudeau resigns:** A Twitter user with 1.2K followers wondered whether the election would be rescheduled in the event LPC Leader Trudeau resigns. Another user (1.4K followers) replied by stating that “election terms are mandated by law,” adding that the LPC would choose a new leader and the election would proceed on the assigned date. The original user continued the exchange by stating “isn’t Oct 21 earlier than the mandate?” The exchange had four engagements.
- **Russian-speaking Canadians skeptical of foreign interference during GE43:** Users in a number of Russian-Canadian news groups are sharing an article discussing potential Russian interference in GE43 and mentioning a CBC interview with Yves Côté, published by the TASS News Agency and others. Several users expressed skepticism, with one writing “entire departments are feeding on this idea [of interference] to sit around and do nothing; preventing threats to milk the budget.” The article was shared in at least four Russian-language news groups, including *Russian Speakers in Canada*, *Daily Toronto News* and *Russian Montreal Blog*, and garnered 80 engagements in total. *(Translation by SMMU staff.)*
- **Reddit user “lodges a complaint” with EC on Canada Proud ad spending:** In a high-engagement thread on r/onguardforthee – a Canadian politics discussion group with 64.4K members – a Reddit user said they had filed an “official complaint” with EC, following a *Global News* story detailing third party Canada Proud’s online ad spending. The user added that ads that “spread misinformation” are “unconstitutional” and “shouldn’t be allowed.” The thread received 275 engagements. The *Global News* story in question, [Canada Proud spent more than \\$100k boosting online posts: Elections Canada docs](#), has elicited strong reader interest (1.3K engagements).

Fait saillants sur les médias sociaux / Social media highlights

Following a blog post by Anti-Racist Canada publishing the names and cities of residence of 250 CNP members, a few comments supportive of the CNP appeared on r/Canada_First, the niche Reddit forum devoted to “Christian Nationalist” ideas. In addition, a frequent poster who identifies himself as a CNP member claimed in two threads that EC had “doxed” party members and “jeopardized the safety of law-abiding, patriotic Canadians.”

In the first thread, the CNP member calls on the CEO to resign and requests a “24/7 security detail.” r/Canada_first users suggested the CNP “sue them,” referring to EC and/or Anti-Racist Canada. Another user suggested that if CNP members were “a bit nicer” to EC in past interactions, they may not have released CNP members’ names to the public. In the second thread, the same CNP member said EC displayed a “willingness to collaborate with Bolshevik terrorists, and to violate [their] Charter Rights in the process.” The two threads received a total of 15 engagements.

A small number of Twitter users shared the link to ARC’s blogpost; two users also posted individual profiles of CNP members. On Facebook, the Canadian Anti-Hate Network’s post on the topic, which included ARC’s blogpost in full, was shared 340 times. The link was also shared on other niche Reddit forums, including r/Canada_Socialism, r/AntifascistsofReddit and r/CanadaLeft, receiving a total of 61 engagements. Overall, the link to ARC’s blog post was shared 2.1K times in 24 hours across social media platforms. No major media outlets have covered the story.

Twitter users continued to react to a 2001 photo showing LPC Leader Justin Trudeau in “brownface” makeup. Some users found it “suspicious” that the photo resurfaced in the middle of an election period and labeled it “foreign interference.” One user claimed that the photo was released by “foreign powers” that want to “hijack the Canadian election,” while other users found it troublesome that the photo was originally released by a “foreign controlled media outlet.” One user directed a tweet to *Time* magazine and asked the media outlet to “stay in its lane.” Some users also commented on other foreign news outlets’ coverage of the 2001 photo, with many expressing dismay that non-Canadian news outlets were weighing in on the story during an election period and one user claiming the photo was released by a U.S. news outlet to “avoid Elections Canada.” Others, including *Rebel Media* commentator Ezra Levant, mocked the suggestion that this was foreign interference.

In a tweet replying to CPC candidate Pierre Poilievre’s observation that LPC Leader Trudeau had not expressed any intention to resign, one user claimed that Mr. Trudeau’s refusal to resign over the 2001 photo constituted “election fraud,” adding that GE42 included “vote rigging” and “buy offs” to EC.

Twitter users continued commenting on the lack of a complete list of candidates on EC's website. Some users expressed confusion, stating that it was "absurd" some ridings did not have a full slate of candidates listed on VIS, while others thought it "weird." In an exchange with EC's official Twitter account, one user who plans to vote at an advance poll, expressed frustration that the September 30 deadline for nominations gives them "only 9 days" to research their candidate.

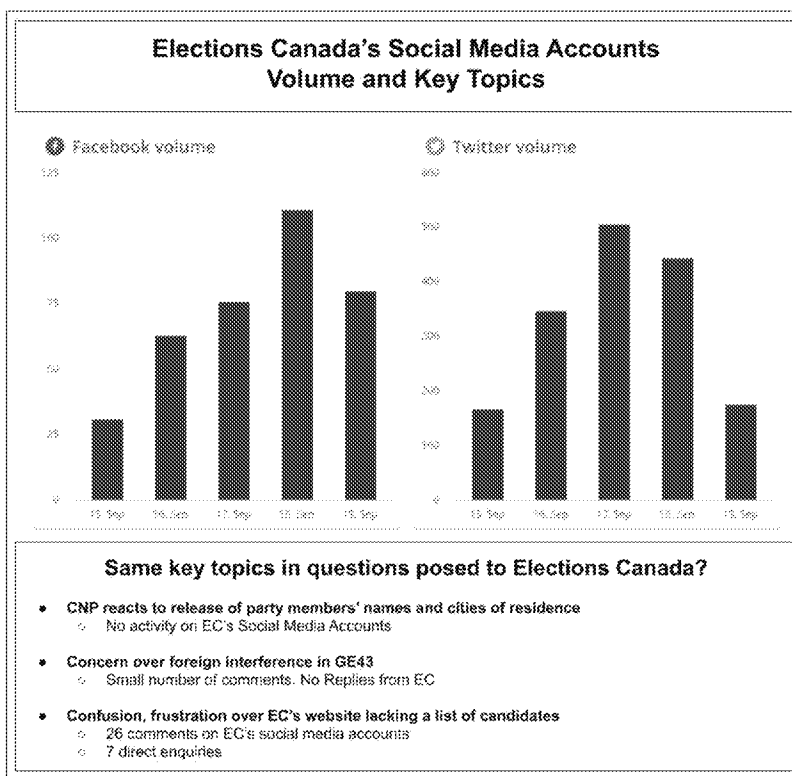
