On May 18, 2004, the overseas Chinese community in Vancouver held a symposium at the Chinese Consulate General in Vancouver to support a cross-strait statement issued by Taiwan Affairs Office of the State Council of China. Vancouver Chinese Benevolent Association, Chinese Cultural Centre, Chinese Freemason, Canadian Association for the Promotion of China's Unification, Canada-Beijing Friendship Association, Chinese College and University Alumni Association, etc.

Representatives from more than 50 overseas Chinese community groups attended the symposium. Reporters from nine local newspapers and TV stations including Ming Pao Daily, Sing Tao Daily, World Daily, Fairchild TV, Channel M (now is Omni TV), Global Chinese Press, and Dawa Business News conducted on-site interviews.

George Chow, president of the Chinese Benevolent Association, said in his speech that as a Chinese Canadian, he is very concerned about the future of the Chinese ethnicity and hopes to see the peaceful reunification of the motherland. Mak Pak-keung, vice chairman of the CBA, said that while emphasizing the five "nos", the Chinese government's statement showed seven bright prospects. Overseas Chinese should unite to jointly stop "Taiwan independence" separatist activities. The "Statement" expresses the common aspirations of overseas Chinese and is a new milestone in Cross-Strait relations.

After the symposium, at the suggestion of representatives of the CBA and Chinese Freemason, the participating groups jointly issued the "Vancouver Overseas Chinese Community's Statement on Current Cross-Strait Relations", which will be published in full in major Chinese newspapers in Vancouver.

#### **Over a hundred overseas Chinese groups support China in defending South China Sea sovereignty**

**The symposium issued a joint statement citing history as testimony**

The Vancouver Chinese Benevolent Association held a symposium yesterday with a large number of local overseas Chinese groups. The theme was: "Support China in defending its sovereignty in the South China Sea." The symposium was attended by dozens of representatives from overseas Chinese groups, and representatives from the National Congress of Chinese Canadians, Chinese Veterans Association, Chinese Cultural Centre and Chinese Freemason and other groups spoke one by one.

At the meeting, the "Solemn Statement of the Vancouver Chinese Community" jointly signed by the overseas Chinese groups was issued, pointing out that China was the first to discover and develop the South China Sea Islands. From a historical and legal perspective, China has indisputable sovereignty over the South China Sea Islands and their adjacent waters.

Hilbert Yiu, president of the Vancouver Chinese Benevolent Association, revealed that the statement has been co-signed by more than 100 overseas Chinese groups. At the meeting, some people also suggested that in addition to issuing a statement, they should also consider whether further actions may need to be taken jointly after the arbitration results come out. It may be necessary to join forces to take further actions, which has received support from many overseas Chinese representatives.

**Strongly condemn the violence committed by lawless elements**

Recently, a small number of radical lawless elements have committed violent acts in Hong Kong, setting up roadblocks, obstructing traffic, and gathering crowds to cause trouble. What is even more serious is the illegal occupation of the Hong Kong International Airport, disrupting the Legislative Council, obstructing government agencies, and besieging the Police Headquarters;

they even stormed the Liaison Office of the Central People's Government, defaced the national emblem of the People's Republic of China, and threw the Chinese flag into the sea. These few lawless elements continue to create violent riots, causing injuries to more than 100 police officers and citizens, blocking public transportation, and grounding nearly a thousand international civil flights, seriously affecting the normal work and life of Hong Kong people; jeopardizing Hong Kong's economy, especially the international financial sector. Hong Kong's status has been severely affected, and Hong Kong's import and export trade, freight, retail, and tourism have been even worse. What's more serious is that this kind of violent behaviour has touched the bottom line of Hong Kong's "one country, two systems". It not only undermines Hong Kong's social security and the normal life of citizens, but also jeopardizes China's national security and peaceful development.

We, the overseas Chinese in Canada, are worried about the current situation in Hong Kong. At the same time, we firmly support Hong Kong's "one country, two systems" and the stability of the legal system; we strongly condemn the violent acts of radical lawless elements; we firmly support the Hong Kong SAR government in upholding the Basic Law of Hong Kong and governing Hong Kong in accordance with the law; we firmly support The Hong Kong Police Force enforces the law strictly to prevent the spread of violent riots and protect Hong Kong's social order and the safety of citizens' lives and property.

Defending the country's territorial integrity is China's sovereignty, and adhering to the "one China" principle is the bottom line for promoting the peaceful reunification of the motherland. Fifteen years ago, in response to the dire situation at that time when "Taiwan independence" separatist activities were escalating, the National People's Congress initiated the legislative

process of formulating the "Anti-separatist State Law." On March 14, 2005, the Third Session of the 10th National People's Congress passed the Anti-Secession Law by a wide margin. The "Anti-Secession Law" is based on the Chinese Constitution. It upholds the principle of "one China" and is a guarantee for the implementation of "one country, two systems" and peaceful reunification. It is a powerful weapon to contain "Taiwan independence" separatists and oppose interference from external forces. The legal basis for China's territorial integrity and national rejuvenation.

On May 29 this year, a symposium on the 15th anniversary of the implementation of the Anti-Secession Law was held in the Great Hall of the People in Beijing. Su Zhanshu, member of the Standing Committee of the Political Bureau of the CPC Central Committee and Chairman of the Standing Committee of the National People's Congress, delivered a speech at the meeting. #### **Canadian values freedom of speech**

As we all know, Canada's core value is "freedom of speech" and everyone can express their opinions.

Retired judge Bill Yee recently called on his compatriots to unite and stated that "the accusations about the Xinjiang incident in China are fabrications and lies." He was criticized by some people with different opinions. They also requested the provincial government of British Columbia to take action to remove Bill Yee from certain volunteer groups.

This move not only blocks the channels of expression, but also discourages those who are interested in serving the community. It is even more suspicious that this unreasonable request is an act of "bullying." It is inconsistent with Canada's "free speech" principle. Therefore, the Vancouver Chinese Benevolent Association must correct it.

### **Suspected of creating anti-Chinese sentiments**

The recent use of the term "genocide" originated from the U.S. State Department's announcement in January 2021, on the last day of the Trump administration's term.

This proposal is suspected of being subconsciously used together with terms such as "Chinese coronavirus" to create "anti-Chinese sentiments" in order to stir up racial hatred.

### **Racial hatred must be stopped**

Since then, attacks on Chinese, overseas Chinese, and Asians in North America have increased by more than seven times. Wildcat-like and unorganized random attacks are increasing day by day. Although most people are bullied, most people do not complain, but it has caused panic among Asians. Now it has been extended to the Internet and has become more and more serious, and it must be curbed.

### **Chinese groups reject the motion**

Many North American Chinese and Asian groups have expressed their stance. The non-binding "Xinjiang motion" passed by Parliament has been called "unsubstantiated gossip", "fabricated rumors" and "interference in other countries' internal affairs". Some have cited figures to show the growth of the Uyghur population in Xinjiang.

Most importantly, it hurts the friendly relations between Canada and China.

### **Parliament Motion Questioned**

The Vancouver Chinese Benevolent Association shoulders the well-being of its fellow members and cares about people's livelihood. It not only actively solicits the opinions of the Chinese community, but also held a board meeting on March 13, 2021, passed a resolution, and issued the following statement:

In 2021, the Canadian Parliament passed a condemnation of "China's Xinjiang genocide."

The Chinese Benevolent Association also sought verification in many aspects, including collecting information online, and concluded that these accusations are actually one of the tactics used in the Sino-US trade war. So far, the accusation has never been proven.

There is no UN resolution and no Human Rights Court judgment. Just like a suspect is innocent until he is convicted in a court of law.

### **Eliminate racial discrimination**

The "International Day for the Elimination of Racial Discrimination", just held on March 21, 2021, aims to cultivate a "global culture of tolerance, equality and anti-discrimination" and calls on "each of us to resist racial prejudice and intolerance" manner".

Under the current raging coronavirus epidemic, the results have not been evident, and all parties still need to go all out to help eliminate racial prejudice.
