

During these 13 years of slanderous and persistent abuse of my civil rights, I have never been interviewed by CSIS regarding their false and unsubstantiated allegations. However, I am aware that they have conducted intimidating interviews with my friends and acquaintances and then instructed them to keep their mouths shut.

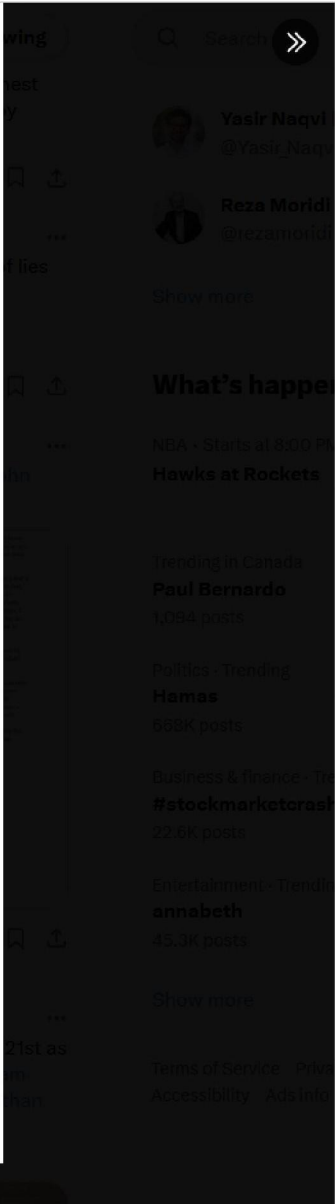
The content of the unlawful sharing of information by CSIS employees violates my privacy and is exceptionally ridiculous and defamatory in reference to my activities in 2019. The fact is that, from late 2018 to late 2019, I travelled extensively outside of Canada to Southeast Asia to develop an overseas project as a private citizen. My travels included multiple meetings with numerous consular officials of Southeast Asian and Asian countries. In between those trips, I returned to Canada to fulfil my responsibilities as a member of the Board of Governors for an educational institution. My absences from Canada would have made it impossible for me to have played any role in the 2019 federal electoral campaign.

In 2017, the current CSIS Director admitted to organizational systemic racism. It is evident to me that this reprehensible workplace climate, described by employees as an "old boys' club", has long spilled over into the conduct of CSIS employees in the wider Canadian society.

Unjustifiably stoking fears of immigrants as disloyal citizens and enemy aliens without concrete evidence is a practice that has led to some of the worst injustices in world history. It serves only to create division, hate, and the destabilization of a peaceful, harmonious, vibrantly diverse society. It also undermines one of Canada's key advantages in the global economy – the deep ties and connections of our multicultural population to nations around the world.

Canadians do not expect that employees of a taxpayer-funded federal agency responsible for national security would indulge in such a despicable practice that in itself undermines the values they should be seeking to uphold.
